Old Business:

Clear Well #1

Council discussed the removal of clear well #1 at the last Council meeting. It was decided to bring the issue up with the Town's engineer. Initially the engineer suggested that clear well one should be removed. He was hesitant if the well's capacity was 60,000 gallons, however, upon further investigation by the Town staff it is clear that the reservoir is not 60,000 gallons. Contamination is a concern for staff and it is recommended that the well be removed. Council discussed the matter at length.
